

## 6Hx19-6.09      STANDARDS OF ACADEMIC PROGRESS

The purpose of this rule is to establish Board policy relating to standards of academic progress for students of Pasco-Hernando State College.

1. All students will be evaluated for academic progress at the end of fall, spring and summer terms. In determining academic progress, college credit, and preparatory credit will be used (includes PHSC and transfer credits).
2. Students must maintain a 2.00 cumulative GPA for all hours attempted. "Attempted" means all credit hours for which a student is enrolled after the drop/add date for course enrollment (excludes "W" grades.)

Students' standards of academic progress will be calculated and fall under the following categories:

**Good Standing:** Students are in good academic standing when the requirements listed above are met.

**Academic Warning:** Students will be placed on academic warning at the end of the first term in which the standards of academic progress outlined above have not been met.

**Academic Probation:** Students will be placed on academic probation at the end of a term if, after being placed on academic warning, the standards of academic progress outlined above have not been met.

**Academic Suspension:** Students will be placed on academic suspension at the end of a term if, after being placed on academic probation, the standards of academic progress outlined above have not been met.

### **Academic Dismissal:**

After being placed in a suspension waiver status, students who do not meet the re-enrollment conditions will be dismissed from the College for one major semester (fall or spring). After being dismissed for one full semester, students are eligible to return to PHSC under previously established conditions of the suspension waiver unless new conditions are warranted. Students must meet with an advisor before being approved to enroll in courses.
